SYNOPSIS Khara JABOLA-CAROLUS related that [REDACTED] told her that [REDACTED] had received a text from someone stating that JABOLA-CAROLUS was in imminent danger. [REDACTED] related to this Officer that everyone took it out of context and the text was referring to JABOLA-CAROLUS losing her job not a threat towards her.

REPORT NARRATIVE

ASSIGNMENT/ARRIVAL:

This Officer was assigned as 2M151, District 1, Uniform Patrol. On Friday, 09-21-18, at about 1057 hours, this Officer was sent to 235 S Beretania Street Room 407, on a threatening via telephone type case. This Officer arrived shortly after.

SCENE/TIME ELEMENT:

This incident took place via telephone on a phone conference for the Hawaii Coalition against Human Trafficking. The incident occurred on the about date and time.

COMPLAINANT: JABOLA-CAROLUS, Khara/F, appeared to be sober and coherent. JABOLA-CAROLUS stated that some people were concerned about what [REDACTED] had said on a phone conference and told her that she should make a police report. JABOLA-CAROLUS related that [REDACTED] called her relating that someone had texted [REDACTED] threatening JABOLA-CAROLUS. JABOLA-CAROLUS then called [REDACTED] and [REDACTED] had told her that [REDACTED] related that someone texted [REDACTED] stating that JABOLA-CAROLUS was in imminent danger. JABOLA-CAROLUS related that those who had told her about it related that she should make report and that she was a little concerned about it. JABOLA-CAROLUS gave this Officer [REDACTED]'S and [REDACTED]'S number.

PERSON PASSING INFORMATION:

[REDACTED] sounded sober and coherent. [REDACTED] related that he was on a phone conference with some people from the Hawaii Coalition against Human Trafficking and does not know the exact words that [REDACTED] had said but related that [REDACTED] had received a text that JABOLA-CAROLUS was in danger. [REDACTED] related that [REDACTED] knew more of what was said.

Most of [REDACTED]'S information was researched online due to the fact that he did not know who he was talking to via telephone.

PERSON WHO CONFIRMED INFORMATION:

[REDACTED] sounded sober and coherent. [REDACTED] related via telephone that she does not know JABOLA-CAROLUS, [REDACTED] or [REDACTED] good but stated that during a phone conference [REDACTED] had brought up that she had received a text from someone and that JABOLA-CAROLUS was in imminent danger. [REDACTED] related that JABOLA-CAROLUS had called her asking about it because [REDACTED] had told JABOLA-CAROLUS about it. [REDACTED] related that she lives on the Big Island and so does [REDACTED] had given this Officer [REDACTED]'S number and she said that she did not see the actual text and does not know what were the exact words said by [REDACTED].

This Officer gathered information that wasn't too personal from [REDACTED] due to the fact that she did not know who she was talking to because it was over the phone. [REDACTED] had given this Officer [REDACTED]'s number.

PERSON WHO GOT THE ACTUAL TEXT:

[REDACTED] sounded sober and coherent. This Officer attempted to call [REDACTED] on Friday and due to her having a [REDACTED] area code number this Officer called from her personal phone but blocked her number. [REDACTED]'S phone went to voicemail and this Officer was going to attempt to call her another time. This Officer finally got ahold her [REDACTED] today and [REDACTED] related the following:

[REDACTED] stated via telephone that the Sheriffs had called her too and asked if HPD had contacted her about this situation. She related that she had told the Sheriffs everything and they told her that there was no threat and that everyone had taken it out of context.

[REDACTED] explained to this Officer that there was no threat made and that she had gotten a text from a [REDACTED] (who she did not state his name) that JABOLA-CAROLUS'S job was at stake and she may lose it. [REDACTED] related that at no time did she say that JABOLA-CAROLUS was in imminent danger. JABOLA-CAROLUS was getting a lot of hate mail according to [REDACTED] and they were worried that she was going to lose her job so [REDACTED] brought it up in the phone conference that she was having with the Hawaii Coalition against Human Trafficking.

[REDACTED] stated that [REDACTED] had told her that he knows JABOLA-CAROLUS and that he'd relay the message to her. Apparently he took what she said out of context and told JABOLA-CAROLUS that she was in imminent danger but [REDACTED] was actually referring to JABOLA-CAROLUS losing her job. [REDACTED] went on about how [REDACTED] is not really [REDACTED] and that his real last name is [REDACTED]. This Office does not know how this ties into everything but figured that whatever was said to this Officer this Officer would write it in this report because she said that the Sheriff's didn't do anything about looking up [REDACTED]. According to [REDACTED] [REDACTED] has a record and she does not know why he's part of the Hawaii Coalition against Human Trafficking.

[REDACTED] stated that she'd send this Officer the text messages that she had received from the [REDACTED] that was no threat to JABOLUS-CAROLUS but instead she sent this Officer 3 separate emails about [REDACTED]

Not all of [REDACTED]'S information was taken down. This Officer only had her name and number and did not ask for personal information due to the fact that she did not know who she was speaking to on the phone. This Officer searched [REDACTED] in the CRS and the other information given was from her HDL. [REDACTED] lives on the [REDACTED] according to her.

DISPOSITION:

RECORDS - There was no physical threat made to JABOLA-CAROLUS. This was all a telephone pass on that got all messed up by the time it got to the end person.
